1. Call to Order

funds going to reserve.

5.2 Department Reports – September

Department Reports were discussed, and Board members were interested in the background of most submissions and made many positive comments.

5.3 Minutes of the September 12, 2022 Friends of the Strathcona County Library Society

David Atkinson reported the Friends had an active meeting. The Friends designated some reserves for the library to buy books in Ukrainian. Plans are underway for fundraisers, including a book sale, gift wrap, and casino.

The Friends may have a new chair, however, there are still Executive positions not yet covered for 2023.

Sharon will send an email to Library Board members with the date of the book sale. If any Board members wish to donate books, they can drop them off at the Circulation Desk. Arrangements can be made for drop off at the delivery area if people wish to donate more than one or two boxes.

5.4 County Councilor Verbal Report

Glen Lawrence reported on some recent successful County events; these included the Alex Janvier exhibition at Gallery@501, and the Indigenous art displayed between County Hall and the Community Centre. Glen also attended a very informative conference on the Circular Economy, which was presented by the Utilities Department. The budget is coming up soon and Council is working hard to keep tax increases minimal.

6.1 Ad Hoc Enterprise Risk Management Committee

6.1.1 Minutes of the September 27, 2022 Committee Meeting

6.1.2 Draft Cyber Security Strategy

Gene Syvenky explained the importance of an Enterprise Risk Management (ERM) plan. Cybersecurity was selected as the first area for focus. Sharon and Cathy Allen attended a workshop on the topic that provided a template for analysis and documentation. Using this information, the Committee drafted a Cybersecurity Strategy. Denise Charbonneau stated the chart was interesting and commended the Committee on their good work. Denise asked what the Board yearly review will look like? Gene said the ERM Strategy is not intended to be cumbersome. Staff are given the opportunity to review the process internally and report to the Board annually. The Board can then determine if the process in place is complete, or ask "Have you considered this?" The Committee have forwarded two policies to the Policy Committee for review: an Information Security Policy, and a Cybersecurity Policy.
